The City of Langley is excited to be sponsoring a community garden in partnership with the Anderson Family and the Gardeners Association. The Langley Community Garden is at the Anderson Farm located on the corner of Fairgrounds Rd. and Al Anderson. If you are interested in renting one of 16 plots for organic vegetable, flower or herb gardening please complete the following application after reading the rules and responsibilities.

## Community Garden Information

Plots are 18 ft x 20 ft with an annual rental fee of \$50.00 payable to the "City of Langley" with this application. We do not want to exclude anyone who wished to participate, if you need to pay on a sliding scale please contact the Gardeners Association. With your rental fee you become a member of the Gardeners Association that manages the garden and determines any additional shared costs for infrastructure improvements or other operating expenses. You can use your plot year-round, or seasonally, depending on your preference. The fee is for one calendar year. Returning gardeners have priority and may request their prior year plot. Gardeners may request a second plot, if space is available. If the gardener chooses not to renew their plot, they are required to clear the soil of all vegetation and leave the soil ready to be cultivated by another gardener.
