I agree that the City shall not be held responsible for any damage by water or other cause resulting from defective plumbing or appliances on the premises supplied with water, installed by the owner or occupant of said premises, and further that in case the supply of water shall be interrupted or fail for any reason, the City shall not be held liable for damages for such interruption or failure, nor shall such interruptions or failures for any period of time be held to constitute a breach of this contract on the part of the City, or in any way relieve me from performing the obligations of this contract.

I understand that upon approval of this application, I am responsible for bi-monthly water base rates to maintain my rights within the water system.

The City reserves the right to shut off water at any time without notice for repairs, extensions, non-payment of any water or sewer charges, or any other reason.

I further agree that all charges for water or sewer service, if not paid prior to delinquency, shall constitute a lien against the above-described premises which may be enforced as provided by law.

I authorize employees/agents of the City of Langley to enter onto property, the subject of this application, during regular business hours. The sole purpose of entry is to make any examination of the property in order to process this application.

I certify that I am the owner of this property or the owner’s authorized agent. If acting as authorized agent, I further certify that I have full power and authority to file this application and to perform, on behalf of the owner, all acts required to enable the jurisdiction to process and review such application. I have furnished true and correct information. I will comply with all provisions of law and ordinance governing this type of application.
